## Appendix – General Terms &amp; Conditions

## 1. Confidentiality and Non-Disclosure:

- a) The Parties recognize that either Party will have access to confidential information of the other. The party making the disclosure is referred to as the Disclosing Party and the party receiving such Confidential Information is referred to as the Receiving Party.
- b) Receiving Party agrees not to use, apply, employ, or exploit, directly or indirectly, any Confidential Information disclosed to it by the Disclosing Party for any purpose except to carry out discussions concerning, and the undertaking of, the Relationship. Receiving Party will not disclose any Confidential Information of the Disclosing Party to third parties or employees of Receiving Party, except third parties and employees who are required to have the information in connection with the relationship, and except as may be required by applicable law.

## 2. Liability of Data

- a) YOUTH4WORK stores all data on cloud and physical servers and will not be liable for any Loss of INSTITUTE's or Candidate's data due to server not functioning due to natural calamities.
- b) If required, INSTITUTE shall download the assessment reports and data as soon the assessment process gets over.

- b) Youth4work is the sole and exclusive owner of the Youth4work Online Platform and all rights, title and interest therein belong solely and exclusively to Youth4work.

## 4. Benefits to the Parties:

## 5. Relationship, Arbitration and Governing Law
